PLVB meeting with SmartWay at COPPE/UFRJ

On Nov. 22 COPPE/UFRJ received Buddy Polovick and Joshua Silverblatt from the SmartWay the sustainable transportation program from the Environmental Protection Agency (US/EPA). Present were the Vice Director of COPPE, Prof. Suzana Kanh-Ribeiro, the Vice Coordinator of the Transportation Engineering Program, Prof. Andrea Santos, Mobilog Laboratory Coordinator, Prof. Lino Marujo, from the Produc-

tion Engineering Program, Freight Transport Laboratory Coordinator, Prof. Márcio D'Agosto, from the Transportation Engineering Program, who is also PLVB's Technical Coordinator, Dr. Luciana Ventura of the State Environmental Institute (INEA), Mr. André De Simone of COMJOVEM and delegates of PLVB Member Companies, who were also able to attend by video conference. The meeting was rich in exchange

of experiences and knowledge, presenting actions focused on sustainability in freight transportation and logistics where these internationally renowned institutions are involved.
